



### CBMA Website FAQ notes:

- **Entry**

- Most of Green Diamond CBMA private working forest lands in Washington and Oregon are open to the public for free. Open areas are posted with 'Closed to Motorized Vehicles' signs.
- Some limited areas are leased and are not open to the Public. These are posted with No Trespassing signs.
- Roads may be closed using signs, barriers such as rocks or soil, or gates. Any of these methods of closure indicate no motorized vehicles are allowed beyond the closure.
- These are actively managed forest lands that are subject to change based on operational needs. Areas may be closed without notice at any time.
- Please note that employees and their families enjoy special privileges on our lands, including motorized access year-round.
- Regardless of the season, all public entry to Green Diamond property is limited to daylight hours (one hour before sunrise and one hour after sunset, per WDFW /& ODFW hunting/fishing regulations) unless otherwise authorized.

- **Motorized use**

- For members of the public, non-motorized access is allowed year round to open roads, except during periods of extreme fire hazard or active operations when lands are posted to prevent entry.
- Roads may be closed using signs, barriers such as rocks or soil, or gates. Any of these methods of closure indicate no motorized vehicles are allowed beyond the closure.
- Vehicles:
  - Motorcycles, ATVs, and UTVs: Not allowed behind gated road or during designated fire risk seasons.
  - Bikes: Allowed on gated and non-gated roads
  - E-bikes: No Ebikes allowed
  - Horses: Allowed on gated and non-gated roads, and trails.
  - Drones: Drones can be used for personal use within state and federal laws.

- **Firearms**
  - Shooting: Target shooters should know and understand that discharge of a firearm or bow by them is a potentially dangerous condition that is their own responsibility and subject to their control. Target shooters assume all risk and liability associated with their activities on Green Diamond CBMA land including injury to themselves or third parties or property damage arising from their discharge of a firearm or bow. Targets may be set up and used on Green Diamond CBMA land using a safe, bermed backdrop with no possibility for escape of bullets, arrows, or shot. No exploding targets or incendiary ammunition, as defined in RCW 76.04.005, may be used at any time. Users should be acutely aware of their surroundings and should set up targets to ensure safety. Users should clean up after themselves and leave no trace. If a Green Diamond rock pit or other area is posted with “No Shooting” signs, shooting is prohibited. All active timber harvest or other forest management areas are automatically off-limits to shooting or hunting of any kind.
  
- **Hunting & Fishing**
  - All hunting and fishing on Green Diamond CBMA property shall be conducted with a current valid hunting and/or fishing license issued by the respective state (Washington or Oregon) and in compliance with the applicable tags, seasons, limits, and other regulations adopted and enforced by the Washington and/or Oregon Department of Fish and Wildlife. Under no circumstances shall any hunting or fishing be conducted pursuant to the hunting regulations of an Indian tribe.
  
- **Dogs**
  - Dogs are welcome on Green Diamond CBMA property. Please always keep them under control to respect the resources and other visitors. We recommend you keep your dog on a leash. Never leave them unattended.
  
- **Camping**
  - Camping is not allowed for the General public. Camping may be allowed by written permission only on Green Diamond CBMA property.
  
- **Firewood**
  - Gathering of firewood is not allowed outside of designated firewood permit zones. Firewood permits may be obtained at the Trout Lake Hardware Store in the spring and fall.
  - From time to time, firewood cutting opportunities become available within the Green Diamond CBMA property, only Permit holders will be authorized to cut firewood for personal use (5 cords or less) within designated firewood cutting areas inside the permit area.
  
- **Foraging**
  - Mushrooms & Berries: These can be picked for personal use only up to 5 gallons per visit. Commercial harvesting is not allowed. Please note however, that Green Diamond CBMA reserves the right to sell commercial harvest permits for their lands and commercial harvesters.
  - Christmas Trees and boughs: These are working forest lands. No cutting of trees or boughs is permitted for any reason.
